

Prospect Town Council  
Regular Meeting  
Approved Minutes  
April 21, 2015

The Regular Meeting of the Prospect Town Council was called to order by Chairman Thomas J. Galvin @ 7:00 P.M. and commenced with the Pledge of Allegiance. The meeting was held at the Prospect Town Hall, 36 Center Street. The meeting was taped.

**Mayor's Report:**

Mayor Robert J. Chatfield introduced a Nonnewaug High School student, Irene Lerner that has chosen the profession of Taxidermy. Ms. Lerner advised that she had learned of the practice from her teacher and she is now the only student in her class studying this field. Ms. Lerner's specimens have included: Owl, Porcupine, Bobcat, Coyote, Quail, Raccoon and Squirrel. Mayor Chatfield and the Council thanked Irene for coming to the meeting.

Mayor Chatfield had advised that he had sent a letter to Thomas P. Clifford III of the South Central Connecticut Regional Water District stating that the Mayor had re-appointed Mr. Robert E. Harvey Jr. as Prospect's representative to the South Central Connecticut Regional Water District's Policy Board. Mr. Harvey's position will expire on June 30, 2018. Mayor Chatfield advised that he has appointed Bill Sereduck, 35 Summit Rd. to the Community School Purchase Committee. Mayor Chatfield advised that he would like to have one more person, preferably in their 20's that went through Community School, as a student to be added to the Committee.
